Application for Full Membership

Full membership in the International Test Commission (ITC) is open to national psychological associations with an interest in testing and assessment.

Traditionally, full membership was open to associations who are members of the International Union of Psychological Science (IUPsyS). Beginning with 2016, full membership is also open to associations who are not members of the IUPsyS, if they are of national standing in educational and psychological testing and the national IUPsyS member has no interest to join the ITC. Full members of the ITC can contribute to ITC projects and help shape the direction of the ITC. They may also vote in the election of officers and council members, on constitutional matters, or on other matters that may arise at general meetings held every two years during the ITC conference.

Through their nominated representative, Full members receive

- The ITC Newsletter TESTING INTERNATIONAL (twice a year),
- The ITC journal, *International Journal of Testing* (issued in four parts each year).
- The ITC President's *Progress Reports* (twice a year),

In addition, Full Members are encouraged to participate fully in ITC's publications, symposia, and other projects.

IMPORTANT. PLEASE NOTE:

One person must be nominated by the Full member organization to be the <u>ITC</u> <u>Representative</u> for that organization. This person should be in a position to ensure the payment of fees, to be in receipt of emails and attachments from the ITC which they may then distribute more widely within the member organization.

They should also be the person who would vote on behalf of the Full member organization when the ITC has meetings of members or in the election of Council members and Officers. The Representative can pass this right onto another member of the member organization, or appoint a temporary proxy, by making this known to the ITC Secretary-General.

The ITC Representative for the Full member will have free access to the ITC Learning Centre website <u>www.itc-learning.net</u>, with the same rights as an Individual member, where they can engage in a range of learning projects for CPD or for qualification purposes.

Full Member Annual Fees:

1000 members or less:	£ 80
1001 to 10,000 members:	£ 225
More than 10,000 members:	£420

- Members are invoiced on the nearest Quarter Day to the anniversary of their membership (Note the Quarter Days are 1st January, 1st April, 1st of July, and 1st of October).
- Fees are accepted by online Stripe payment either with a credit card or on a PayPal account.
- We regret that we are unable to accept payments in cash or by cheque.

Learning Centre Assessment charges:

Employees or members of your organization can get discounts on the costs of ITC Assessments where external assessors are required for qualification purposes. For example:

- 1. The standard fee for a Level 2 Test User Certification assessment is £760.
- 2. If you are an individual member of ITC, you get a standard discount. So, a fee of £760 would become £685.00.
- 3. Members of your organization get a further 10% discount on the Learning Centre assessment fee and would only pay £610.00.

You will be provided with a <u>Discount Reference Number</u> that you can give to anyone who may legitimately claim a discount on individual fees through their association with your organization.
